#### \*\*\*\*\*ENTRY RULES\*\*\*\*

- 1. FULL PAYMENT MUST ACCOMPANY ENTRY BLANK or a \$25 fine will be assessed. There is a \$25 returned check fee. All fines must be paid in full prior to participation in this rodeo.
- 2. No abuse of livestock in or around the arena will be tolerated. Offenses may result in disqualification.
- 3. Western attire, cowboy hat or AMPAC ranch rodeo cap, long sleeve buttoned down shirt, cowboy boots
- 4. Steer Stopping: Roper calls for the animal, chases it down the arena, ropes it around the neck, horn or half head. Once the catch is made, the contestant dally's and stops the horse. Time is taken when dallied and horse makes a solid stop. Animal does not have to be facing the horse. 30 seconds time limit
- 5. Team sorting (Team of 3): Time starts when first rider crosses the start line. Number will be called out when rider crosses the line. The cows are sorted in order; if any part of a numbered cow crosses the start/foul line prior to its correct order, then the team receives a no time. If any part of a sorted cow re-crosses the start/foul line the team will be disqualified. Two minute time limit.
- 6. Reverse Team Roping: Time starts when steer is let out of chutes. Team ropers start at the opposite side of the arena in the catch pen alley. Gate will open, team ropers run head on to steer, turn around and rope steer going towards catch pen. Time is stopped when team is faced. 45 second time limit, 2 loops. Short go, all times will be zeroed out, no aggregate, fastest time in short go wins.
- 7. Open Team Branding (Team of 4): Head catches must be a head, head with one front leg or figure eight is OK on one but not two front feet. Calf must be headed before heeler can make his catch. The heeler may catch one or both hind feet. The ground crew may assist in removing illegal catches or dropped ropes but must return to the designated area before another loop is thrown. As soon as calf is headed and heeled, ground crew may leave designated area, throw calf, place head rope on both front feet and, if necessary, place heel rope on both hind feet. You may carry the iron with you. The iron cannot touch the ground and the calf can't be branded until all 4 four feet are stretched. All four feet must remain in the stretched ropes while brand is placed on calf. Brand must be properly placed. A misplaced or upside down will be a disqualification. After first calf is branded the ground crew will switch with the ropers and rope the last calf. On the last calf, after the brand is placed, the ground crew returns to the designated area and puts the iron in the bucket for time. 5 minute time limit.
- 8. Trailer Loading (Team of 4): Two steers in arena. Muley must be roped, head and heel, then tied down. Once tied down, rope is removed from head and ropers rope horn steer. Load in trailer, no horses allowed in trailer. Once steer is loaded and gate shut time will stop. Tied calf cannot by held down or undone before gate closes on trailer, if so it results in a no time. 4 minute time limit.
- 9. Wahine Ranch Breakaway: Ropers carries two loops. Time starts when 2 steers are let out of the roping chute. Roper starts at end of the arena, runs down and ropes both steers. Rope must pass over the head. 45 second time limit
- 10. ALL CONTESTANTS MUST BE READY TO COMPETE WHEN CALLED UPON. IF CONTESTANTS ARE NOT READY WHEN CALLED, STOCK WILL BE TURNED OUT AND/OR A NO TIME WILL BE GIVEN.
