8. **Wahine Mugging:** Will be roped. Open Catch Pen.
9. **Wahine Breakaway:** Must supply your own string. Heeler Box Only. Open Catch Pen.
10. **Double Mugging:** Rope must pass over steers head. **Absolutely No Dragging Animal To Partner.**
11. **Kane Wahine Ribbon Mugging:** Rope must pass over steers head. Roper & Mugger must touch the steer and run with rope & ribbon in hand to barrel. **Absolutely No Dragging Animal To Partner.**
12. **Team Sorting:** Sort a herd of cattle in numerical order and drive them across powdered line. Cattle must not cross back or you will have to start over. The team with the fastest time wins. 90 sec time limit.

Further, on behalf to myself, my heirs, successors, representatives, and I hereby unconditionally release all claims and cause of action against the equine activity sponsor, Ka'u Roping & Riding Association Inc., their officers, directors, representatives and show personnel, for any injuries including death and for any damages for my personal property, which may incur as a result to my participation in this equine activity. If the undersigned is a Parent/Guardian, or representative of any minor participating in this equine activity, the undersigned agrees to indemnify the Ka'u Roping & Riding Association Inc. (including its/their-describe related person(s) and entities.) From all claims and causes of action brought on behalf and said minor at any time. I also agree to abide by ALL rules and regulations set forth by the Ka'u Roping & Riding Association Inc.
